**NOTE:** Laws and regulations in this brochure are paraphrased for easier understanding and are intended only as a guide. The official Colorado statutes and regulations are available on our website or DOW offices.

## STATE WILDLIFE AREA DIRECTORY

This brochure features regulations governing Colorado's state wildlife areas (SWA) and state fish units (SFUs). All fishing regulations now will be included in the DOW's 2009 fishing brochure, available in mid-March. Some SWAs may have specific fishing restrictions; anglers should consult a current fishing brochure to make sure they comply with state fishing regulations. Maps of SWAs can be found on our website.

## DOW PROPERTY REGULATIONS

Except if specifically authorized, these activities are **prohibited** on lands, waters, frozen surfaces of waters, rights-of-way, buildings or devices under DOW control. See "Alphabetical List State Wildlife Areas" for regulations on specific properties.

1. To enter, use or occupy an area when posted against entry, use or occupancy.
2. To enter, use or occupy an area for commercial purposes or to do land, water, oil, gas or mineral investigations, surveys or explorations.
3. To operate a vehicle (motorized or non-motorized) except on established roads or within designated camping or parking areas. Drivers must obey Colorado motor vehicle laws.
4. To drive above posted speed limits or above 25 mph if not posted.
5. To leave camp, tent, shelter, motor vehicle or trailer unattended more than 48 hours, to camp or to park travel trailers or campers on SWAs more than 14 days in 45-day period.
6. To establish a permanent structure or plant vegetation. Only portable blinds, tree stands and steps can be erected on SWAs. No nails can be driven into trees. Man-made materials for blinds or tree stands must be removed 10 days after the season when they are used ends.
7. To remove, modify or destroy a building, water control device, fence, gate, sign, survey or section marker, vegetation or objects of archaeological, geological or historical value.
8. To litter, leave fish, entrails, human waste, waste water, containers or toxic substances; to bring household or commercial trash or toxic substances to an area for disposal; or to dump trailer waste in a sanitary facility.
9. To build fires without precautions to prevent it from spreading; to leave fires unattended.
10. To graze livestock. Horses, mules, llamas, burros may be used in wildlife activities.
11. To have or use fireworks, explosives, poisons, herbicides, pesticides or illegal substances.
12. To release wildlife or privately owned game birds. Private game birds may be released for field trials, including group dog training on state wildlife areas only where specifically allowed. To allow dogs, cats or domestic pets to run at large (not on a leash), except dogs used while hunting, while training hunting dogs or during DOW-authorized field trials.
13. To dig trenches, holes or pits.
14. To leave boats, rafts or other floating craft beached, anchored, moored or docked unattended overnight except in areas designated.
15. To fish from DOW boat ramps or docks in conflict with boaters or as posted.
16. To snorkel, scuba dive or spearfish with a diving mask, swim fins, snorkel or air tanks. The exception is where swimming is permitted, when location is identified by a "divers down flag" and when scuba diver has valid S.C.U.B.A. certificate from recognized S.C.U.B.A. training organization.
17. To engage in illegal activities.

18. To use air or gas-inflated floating devices for transportation on or across surface of the water unless the device has multi-compartments and a rigid motor mount when propelled by gasoline or electric motors. Single-compartment air or gas-filled flotation devices are restricted to designated swimming areas.
19. To promote, sponsor, conduct or participate in boat regattas, paintball shooting, questing or non-wildlife oriented activities.
20. To land aircraft.
21. To leave decoys or anything used as decoys in the field or on water overnight.
22. To swim except in designated waters or authorized water contact activities.
23. To discharge a firearm or bow in parking, camping or picnic areas.
24. To fish in fish rearing ponds or raceways on DOW hatchery properties.
25. To conduct field trials or group dog training without a field trial license.
26. To have, store or use hay, straw or mulch not certified as noxious weed free. Certified materials must be clearly marked by certifying state or province. People who transport these materials on federal, state or county roads that cross DOW property are exempt. Also exempt is hay produced on State Trust Lands leased from DOW for wildlife recreation.
27. To trap unless done according to statutes and regulations.
28. To enter an SWA without a habitat stamp. Non-hunting mentors accompanying youth hunters are not required to have a habitat stamp.
29. To use internet or other computer-assisted remote while fishing. Anglers must be physically in the immediate vicinity while fishing.
30. All vessels and floating devices, their contents, motors, trailers and equipment are subject to inspection by the DOW before being launched, operated on or leaving waters on state wildlife areas. Any aquatic nuisance species found during inspection must be removed and disposed of properly according to DOW procedures before vessels are allowed to be launched, operate on or leave the water.

### HABITAT STAMP

A Colorado Wildlife Habitat Stamp is required of people 19-64 who buy hunting or fishing licenses. With a license purchase, the stamp is \$5 and is required on each of the first 2 licenses bought per year (\$10 total). A Habitat Stamp also is required of all people 19-64 who visit a state wildlife area or state trust land leased by the DOW. Without a license purchase, the stamp costs \$10.25 (25-cent search and rescue fee). A lifetime stamp is \$200.

## ALPHABETICAL LIST OF STATE WILDLIFE AREAS

### ADAMS SWA - Routt County

From Steamboat Springs, go E on Hwy 40; turn S on Hwy 131. At CR 14, go S. SWA 1/2 mile N of Stagecoach State Park.

HUNTING: elk, deer, rabbit, dusky (blue) grouse.

RECREATION: wildlife viewing.

FACILITIES: rest room.

RESTRICTIONS:

- a. Closed Dec. 1-July 1.
- b. Camping, fires prohibited.
- c. Dogs prohibited except as aid in hunting grouse.
- d. Vehicles prohibited beyond parking area.

### ADOBE CREEK RES. SWA (Blue Lake) - Bent, Kiowa counties

From Las Animas, go 15 miles N on CR 10. 5,147 acres.

HUNTING: deer, antelope, rabbit, pheasant, scaled quail, dove, waterfowl.

FISHING: warmwater.

RECREATION: boating, sail boating, sail surfing, waterskiing, camping, hiking, wildlife viewing.

FACILITIES: rest rooms, boat ramps.

RESTRICTIONS:

- a. Closed 1 hour after sunset to 1 hour before sunrise except fishing.
- b. ATVs, dirt bikes, snowmobiles prohibited.
- c. Frozen surface of lake closed.

d. Dams, inlets, outlet structures closed except fishing.

**ALBERTA PARK RES. SWA - Mineral County**

From South Fork, go 18 miles W on Hwy 160 to Wolf Ck Ski Area; drive through parking lot. Continue 1.7 miles on USFS Rd 391. 240 acres.

FISHING: coldwater lake.

RECREATION: wildlife viewing.

FACILITIES: primitive boat ramp.

**ALMA SWA - Park County**

From Alma, go 1 1/2 miles N on Hwy 9 to CR 4; then 1/4 mile NW.

FISHING: coldwater stream.

RECREATION: wildlife viewing, camping.

FACILITIES: rest rooms, campsites.

**ALMONT TRIANGLE SWA - Gunnison County**

From Almont, go 3 miles N on Hwy 135.

HUNTING: deer, elk, bighorn sheep, dusky (blue) grouse.

RECREATION: hiking, wildlife viewing.

RESTRICTIONS: Closed Dec. 20-March 31.

**ANDREWS LAKE SWA - San Juan County**

From Durango, go 39 miles N on Hwy 550 to access road; then 1/2 mile E.

FISHING: coldwater lake.

RECREATION: picnicking, wildlife viewing.

FACILITIES: rest rooms, trailhead, parking, overlook.

**APISHAPA SWA - Las Animas County**

From Walsenburg, go 18 1/2 miles NE on Hwy 10 to property sign; turn SE and go 20 miles past Mica Butte. 7,935 acres.

HUNTING: deer, antelope, bighorn sheep, rabbit, scaled quail, dove.

RECREATION: hiking, wildlife viewing.

**ARKANSAS RIVER SWA - Prowers County**

From Holly, go 4 miles E on Hwy 50 to CR 39. Go 3/4 mile S across canal; then 1/2 mile W. 98 acres.

HUNTING: deer, rabbit, squirrel, pheasant, bobwhite quail, dove, waterfowl.

FISHING: warmwater.

RECREATION: camping, hiking, wildlife viewing.

**ARKANSAS RIVER/SALIDA SWA - Chaffee County**

From Poncha Springs, 4 miles N on Hwy 285; 1/8 mile E on CR 165. Parking at W end. From Salida, NW on Hwy 291 for 3 1/2 miles. Go 3/4 mile S on CR 150; 1/2 mile SW on CR 166 to N bank of Arkansas River. Parking E side of road. 27 acres.

FISHING: coldwater stream, Arkansas River. (Note: Fishing access may not be on both sides of river. Check for signs.)

**ATWOOD SWA - Logan County**

From Atwood, go 3 miles SW on Hwy 6 to CR 29.5; then 1/2 mile S. 180 acres.

HUNTING: deer, rabbit, squirrel, pheasant, turkey, bobwhite quail, dove, waterfowl.

RECREATION: wildlife viewing.

RESTRICTIONS:

a. Camping, fires prohibited.

b. Target practice prohibited except if authorized by area wildlife mgr.

c. Discharging firearms or bows prohibited except when hunting. Discharging bows allowed for bowfishing.

d. All recreational activities except deer hunting prohibited opening weekend of regular plains rifle deer season, and opening day and first weekend of late plains rifle deer season.

e. Horse use prohibited except when training hunting dogs and then only allowed in Feb., March and April (through Wed. before spring turkey season opens) and Aug.

f. Beginning on first day of the regular duck season through last day of regular duck season, waterfowl and small game hunters must check out at designated check station. Access from designated parking areas only.

**BADGER BASIN SWA - Park County**

From Hartsel go E and W along Hwy 24; directly N of Hartsel; and N and S along Hwy 9. 22 miles of fishing access.

RESTRICTIONS:

a. Hunting, camping, fires prohibited.

b. Parking only in designated areas.

c. Access only from designated parking areas. Closed beyond fenced and posted easement.

**BANNER LAKES SWA - Weld County**

From Hudson, go 4 miles E on Hwy 52. 934 acres.

HUNTING: pheasant, dove, waterfowl.  
FISHING: warmwater.  
RECREATION: hiking, wildlife viewing.  
FACILITIES: rest rooms.

**RESTRICTIONS:**

- a. Boating prohibited except for hand-propelled craft and float tubes.
- b. Camping, fires, horseback riding, bicycling prohibited.
- c. Discharging firearms or bows prohibited except when hunting or training dogs. Discharging bows allowed for bowfishing.
- d. Fishing prohibited from opening of first regular duck season to last day of waterfowl season.
- e. Closed from first day of regular waterfowl season to the day before first day of pheasant season except waterfowl hunting Sat., Sun., Mon. and legal holidays. Reservations required for waterfowl hunting during this period. Reservations by calling 1-800-846-9453. Reservations not accepted more than 14 days nor less than 48 hours before hunt date. Failing to cancel may result in losing future reservation rights. Max. 1 reservation per day; 1 reservation per phone call. Reservations not transferable. Whoever makes reservation must be licensed hunter and be at property day of hunt. Mandatory check in and check out. Access only through designated area.
- f. Closed N of Hwy 52 April 1-July 15.
- g. Dog training permitted north of Hwy 52 during Feb., March, July 16-Aug. 31 only. Dog training permitted S of Hwy 52, Feb. 1-Aug. 31 only.
- h. Foot access only.
- i. Field trials may be authorized Feb., March and Aug. No more than 4 per year. Group training events not limited.
- j. Privately owned game birds may be released by special permit for field trials and dog training S of Colo. 52.

**BASALT SWA - Eagle, Pitkin counties (Basalt, Christine, Toner, Peachblow, 7 Castles, Schuck)**

TONER UNIT: From Basalt, go 3.2 miles E on USFS Rd 105 (Fryingpan Rd) to signs; then N. 2,577 acres.

CHRISTINE UNIT: From Basalt, go 1/2 mile W on Two Rivers Rd (old Hwy 82) to Homestead Dr; then go N to access road. 2,230 acres.

HUNTING: deer, elk, bighorn sheep, dusky (blue) grouse.

FISHING: coldwater stream, coldwater lake.

RECREATION: picnicking, wildlife viewing.

FACILITIES: shooting range.

**RESTRICTIONS:**

- a. Alcohol prohibited on shooting range.
- b. Except for muzzleloaders, firearms on shooting range restricted to those lower than .50 caliber. Fully automatic firearms prohibited. Discharging firearms on shooting range allowed only Mon.-Fri. 7 a.m. to 7 p.m., and Sat. and Sun. 9 a.m. to 7 p.m.
- c. Boating, water activities prohibited on Lake Christine.
- d. Camping prohibited within 1/4 mile of Fryingpan River.
- e. Camping prohibited except during regular and late big game seasons, plus 3 days before and 3 days after the seasons.
- f. Closed Dec. 1-April 15 except on Lake Christine and rifle ranges.
- g. Fires, mountain bikes prohibited.
- h. Dogs prohibited except field trials may be authorized Aug. and Sept.

**BEAVER CREEK SWA - Fremont County**

From Canon City, go 8 miles E on Hwy 50 to Hwy 67; then N 2 miles to CR 132, then E 0.2 miles to CR 132, then N 9 miles to property. Or: From Skaguay Dam, downstream 12 miles on trail to ppty. 2,120 acres.

HUNTING: deer, bighorn sheep, rabbit, turkey, dove.

FISHING: coldwater stream.

RECREATION: hiking, wildlife viewing.

**BEAVER CREEK RES. SWA - Rio Grande County**

From South Fork, go 2 miles SW on Hwy 160 to USFS Rd 360 (Beaver Ck Rd); then 6 miles S.

FISHING: coldwater lake.

RECREATION: wildlife viewing.

FACILITIES: campgrounds (USFS), rest room, drinking water, boat ramps.

**RESTRICTIONS:**

- a. Discharging firearms prohibited.
- b. Open fires prohibited on ice.
- c. Boating prohibited if it creates a whitewater wake.
- d. Bowfishing prohibited.

**BEAVER LAKE SWA - Gunnison County**

From Marble, go 1/4 mile E on CR 3. 41 acres.

FISHING: coldwater stream, coldwater lake.

RECREATION: non-motorized boating, wildlife viewing.

RESTRICTIONS:

- a. Boating prohibited except for float tubes or hand-propelled craft.
- b. Camping, fires, discharging firearms or bows prohibited.
- c. Vehicles prohibited on dam.

**BEAVER RES. SWA (Minnesota Creek) - Gunnison County**

From Paonia, go E on 0-50. Go to USFS Rd 710.

FISHING: coldwater lake.

HUNTING: big game access.

**BELLAIRE LAKE SWA - Larimer County**

RESTRICTIONS: Boating prohibited except for float tubes or craft propelled by hand, wind or electric motor.

**BELLVUE SFU - Larimer County**

N of Ft. Collins on Hwy 287 to LaPorte. Just N of LaPorte go W on CR 28. 58 acres.

RECREATION: limited public use, limited tours.

RESTRICTIONS: Hunting, dogs prohibited.

**BERGEN PEAK SWA - Clear Creek, Jefferson counties**

From Evergreen, go 4 miles N on Hwy 74 to Hwy 103; then 5.9 miles W to Stinton Rd. Go 2.2 miles E.

HUNTING: deer, elk, squirrel, dusky (blue) grouse.

RECREATION: hiking, horseback riding.

RESTRICTIONS:

- a. Foot or horseback only.
- b. Camping, fires prohibited.
- c. Dogs must be on leash except when hunting small game.
- d. Discharging firearms or bows prohibited except when hunting.

**BIG BEND SWA - Chaffee County**

From Mt. Shavano Fish Hatchery, NW about 6 miles along Arkansas River. Access from Mt. Shavano NW on CRs 160, 163 & 166. Access from N end from Poncha Springs, 4 miles N on Hwy 285, 1/8 mile E on CR 165.

**BIG MEADOWS RES. SWA - Mineral County**

From South Fork, go 11 miles W on Hwy 160 to USFS Rd 410; then 2 miles W.

FISHING: coldwater lake.

RECREATION: wildlife viewing.

FACILITIES: campgrounds, rest room, drinking water, boat ramp.

**BIG THOMPSON PONDS SWA - Larimer County**

From Loveland, go 5 miles E on Hwy 402 to I-25 Frontage Rd; then 3/4 mile N to interstate underpass. Go left through underpass; then 1/4 mile N. 51 acres.

HUNTING: rabbit, dove, waterfowl.

FISHING: warmwater.

RECREATION: picnicking, wildlife viewing.

FACILITIES: rest room.

RESTRICTIONS:

- a. Boating prohibited except for float tubes used while fishing.
- b. Camping, fires, dog training, horseback riding, bicycling prohibited.
- c. Discharging firearms or bows prohibited except when hunting. Discharging bows allowed for bowfishing.
- d. Closed 1 hour after sunset to 1 hour before sunrise except when fishing or with night hunting permit.

**BILLY CREEK SWA - Montrose, Ouray counties**

BILLY CREEK TRACT: From Montrose, go 16 miles S on Hwy 550 to Ouray CR 2, then turn left. Road also leads to Nicoll and Porter tracts.

COLONA TRACT: From Montrose, go 7 miles S on Hwy 550 to Government Springs Rd. Continue on Horsefly Rd to signed access road.

CARMICHAEL TRACT: From Montrose, go 21 miles S on Hwy 550 to Ouray CR 8, turn left on lower road. Go through ranch yard; then go 1 1/4 miles on main road to access road.

BECKETT TRACT: From Montrose, go 18 miles S on Hwy 550 to Ouray CR 4; turn left. Go 1/2 mile. 5,498 acres, all tracts.

HUNTING: deer, elk, rabbit, dove.

FISHING: coldwater stream, pond.

RECREATION: wildlife viewing, camping, hiking.

**RESTRICTIONS:**

- a. Snowmobiles prohibited on Colona tract.
- b. Closed Jan. 1-April 30.

**BITTER BRUSH SWA - Moffat County**

**RESTRICTIONS:**

- a. Closed Jan. 15-April 30.
- b. Camping, fires prohibited.
- c. Vehicles allowed only on CRs 59 and 143.

**Blacktail Conservation Easement - Routt County.** 610 acres.

**RESTRICTIONS:**

- a. Closed Dec. 1-May 31.
- b. Foot or horseback only June 1-Nov. 30.

**BLISS SWA - Larimer County**

From Laporte, go 5 miles N on Hwy 287 to Hwy 14; then 41 miles W. 352 acres.

HUNTING: deer, elk, bighorn sheep, rabbit, dusky (blue) grouse.

FISHING: coldwater stream.

RECREATION: wildlife viewing.

RESTRICTIONS: Boat launchings, takeouts prohibited.

**BLUE RIVER SWA - Summit County**

BLUE RIVER UNIT: From Silverthorne, go 17 miles N on Hwy 9. 82 acres.

EAGLE'S NEST UNIT: From Silverthorne, go 9 miles N on Hwy 9. 29 acres.

SUTTON UNIT: From Silverthorne, go 7 miles N on Hwy 9.

FISHING: coldwater stream.

RECREATION: picnicking, hiking, wildlife viewing, watchable wildlife trail

RESTRICTIONS:

- a. Camping, fires, discharging firearms or bows, firewood cutting prohibited.
- b. Vehicle parking overnight prohibited.
- c. Habitat stamp not required to enter Blue River Unit parking lot E of Hwy 9.

**BODO SWA - La Plata County**

From Durango, go 1 mile S on Hwy 160/550 to CR 211; then 1/4 mile W to E boundary.

HUNTING: deer, elk, rabbit, dusky (blue) grouse, band-tailed pigeon, dove.

RECREATION: picnicking, hiking, wildlife viewing.

RESTRICTIONS:

- a. Camping, fires, snowmobiles prohibited.
- b. Discharging firearms prohibited except when hunting.

**BOEDECKER RES. SWA - Larimer County**

From Loveland, go 2 miles W on First St to CR 21; then 1/2 mile S. 308 acres of water.

HUNTING: dove, waterfowl.

FISHING: warmwater.

RECREATION: wildlife viewing.

FACILITIES: boat ramp.

RESTRICTIONS:

- a. Boating prohibited if it creates a whitewater wake.
- b. Fishing prohibited from boats Nov. 1 to end of waterfowl season.
- c. Camping, fires, horseback riding, sailboards prohibited.
- d. Discharging firearms or bows prohibited except when hunting. Discharging bows allowed for bowfishing.
- e. Closed 1 hour after sunset to 1 hour before sunrise except when fishing or with night hunting permit.

**BOSQUE DEL OSO SWA - Las Animas County**

From Trinidad, take exit 14A off I-25. Go W on Hwy 12 approx. 21 miles to Weston and look for access signs between Weston and Stonewall. Property S of Hwy 30,000 acres.

HUNTING: deer, elk, bear, turkey, small game, mtn. lion.

FISHING: coldwater stream.

RESTRICTIONS:

- a. Campfires prohibited except in designated areas
- b. Discharging firearms or bows prohibited except while hunting. Discharging bows allowed for bowfishing.
- c. Camping prohibited outside designated areas except by hunters during hunting seasons.
- d. Parking allowed only in designated areas.
- e. Unattended food or garbage only allowed in bear-resistant manners.
- f. Snowmobiles, motorized vehicles, ATVs and bicycles on established roads or trails may be prohibited to protect wildlife and prevent resource damage. Closures posted.
- g. Closed Dec. 1-March 31, except licensed big game hunters and one non-hunting companion.

h. Fishing prohibited on S Fork of Purgatoire River in SWA from day after Labor Day weekend until first day of Memorial Day weekend. .

**BRAVO SWA - Logan County**

From I-76 at Sterling exit, go 1/2 mile W on Hwy 6 to CR 370; then 1.7 miles NE. 1,082 acres..

HUNTING: deer, rabbit, squirrel, bobwhite quail, pheasant, turkey, dove, waterfowl.

RECREATION: wildlife viewing.

**RESTRICTIONS:**

- a. Camping, fires prohibited.
- b. Discharging firearms or bows prohibited except when hunting.
- c. Target practice prohibited except if authorized by area wildlife mgr.
- d. All recreational activities except deer hunting are prohibited on opening weekend of regular plains rifle deer season, and opening day and first weekend of late plains rifle deer season.
- e. Field trials may be authorized Feb., March and Aug. Trials limited to 1 per year.
- f. Horse use prohibited except when training hunting dogs and then only allowed in Feb., March and April (through Wed. before spring turkey season opens) and Aug.
- g. Access only from designated parking areas.
- h. Beginning on first day of regular duck season through last day of regular duck season, only hunting allowed. Waterfowl and small game hunting by reservation by calling 1-800-846-9453. Reservations not accepted more than 14 days nor less than 48 hours before hunt date. Failing to cancel reservations may result in losing future reservation rights. Max. 4 people per reservation.
